Child protection working group (March to May 2022)

GOALS:

- a) To establish clear mandates as well as roles and responsibilities for the stakeholders on the flowchart.
- b) To establisch clear standard operating procedures (SOPs) with time-frames for each stakeholder.
- c) To strengthen communication and collaboration between service providers so that children can receive quality support services from the child protection sector through a victim-centred, trauma informed approach to child protection care.
- d) To implement a community-based resilience approach (building circles of support around children and community members) so that social change can happen from the bottom up (that acknowledge people's lived experiences).
- e) Liaising with SAPS/FCS and exploring long-term practical and debriefing support to them.
- f) Increasing community awareness around issues such as human rights, child trafficking etc.
- g) Strengthening of the Thuthuzela Care Centre.

CURRENT FOCUS:

For 2022, the working group has identified the big need for trauma debriefing of child protection stakeholders. Together, we are exploring how trauma-informed service providers look like and what is needed to support child protection stakeholders with resilience-building skills and debriefing opportunities through collaboration.

PROGRESS

A forum was established between Ezrah, the Department of Social Development and the Western Cape Department of Community Safety together with several counter trafficking non-profit organisations. As a result of forum meetings, the following outcomes were achieved during this time period (March-May 2022:)

- Since the start of the forum, the following stakeholders joined the forum and are actively participating in it: A21, Freedom Ports Alliance, Free to Fly, Department of Social Development, Cause for Justice (CASE-SA), Love Justice, The Justice Desk, Dr. Joan van Niekerk, Missing Children South Africa, Cape Winelands Department of Health, Molo Songololo, the Real Deal Trust, Stop Trafficking of People and S-Cape.
- An online forum meeting was held on 9 May 2022 to prepare for the Think Tank in line with the SOP for Integrated Assistance to Victims of Trafficking.
- An in-person Think Tank was hosted by Ezrah Community Training and Development NPC on the 23rd of May 2022 to pave the way forward.
 Several action points were identified including the establishment of a training task team as well as a multi-disciplinary task team for the Cape Winelands.

 We are also looking forward to strengthen value-based service principles in our joint approach such as Batho Pele (People first) and to advance training



ONLINE DEVELOPMENT AND COMMUNICATION

In line with our digital strategy, Ezrah is very excited about the progress we are making to empower more people through our online resources and courses.

Our website resource page on child protection provides valuable free resources for child protection stakeholders - see https://www.ezrah.co.za/child-protection-resources/. This includes ideas to celebration Child Protection Month, resources that create awareness around child trafficking as well as the following protocols:

- a) Recommended use of photos of children
- b) Reporting protocol to report child abuse

We believe ethical thinking is key in providing quality services to children. During May 2022, the Ezrah team was delighted to launch our first Ebook, Think Ethics for Non-profit organisations on our online shop - see https://www.ezrah.co.za/shop/. Within the next few months, we aim to add an Ethics workbook, facilitator's handbook as well as short courses to our online platforms.

We are also planning to launch child protection online courses within the next few months in our effort to encourage churches, ECDs and other organisations working with children to develop and implement child protection policies.

SUPPORT NEEDED




