



Child protection working group (June to August 2022)

GOALS:

- a) To establish clear mandates as well as roles and responsibilities for the stakeholders on the flowchart.
- b) To establish clear standard operating procedures (SOPs) with time-frames for each stakeholder.
- c) To strengthen communication and collaboration between service providers so that children can receive quality support services from the child protection sector through a victim-centred, trauma informed approach to child protection care.
- d) To implement a community-based resilience approach (building circles of support around children and community members) so that social change can happen from the bottom up (that acknowledge people's lived experiences).
- e) Liaising with SAPS/FCS and exploring long-term practical and debriefing support to them.
- f) Increasing community awareness around issues such as human rights, child trafficking etc.
- g) Strengthening of the Thuthuzela Care Centre.

Exciting progress:

- We are collaborating with Sp(i)eel Arts Therapies Collective to promote the implementation of a debriefing project for selected child protection stakeholders: (FCS SAPS and Thuthuzela Care Centre).
- We equipped members of the working group with a trauma-informed plan to develop trauma-informed practice within their respective organisations.

PROGRESS

The Western Cape Counter Child Trafficking forum was established between Ezrah, the Department of Social Development and the Western Cape Department of Community Safety together with several counter trafficking non-profit organisations. As a result of forum meetings, the following outcomes were achieved during this time period (June to August 2022):

- The Western Cape Provincial Task Team on Trafficking invited Ezrah to collaborate on a Community Awareness Session to celebrate World Day Against Trafficking in Paarl. We partnered with Valcare and Inceba Trust to mobilise community leaders and held a very successful community session on the 28th of July 2022 with about 120 persons in attendance. - As a result of the event, we connected different stakeholders within one another to facilitate collaboration around countering child trafficking.
- We had several counter trafficking planning engagements during this time period and are excited to launch two working groups related to the forum during September. The working groups will focus on counter trafficking training and multi-disciplinary case management.
