To strengthen the larger child protection (CP) system in South Africa through collaboration and through empowering child-focused organisations as child protection champions.

Direct beneficiary reach:

INTRODUCTION

Celebrating Child Protection

In the midst of alarming child abuse and neglect statistics, we find great hope when organisations unite to collaborate on child protection. Therefore, we are so proud of the members of our Child Protection Empowerment Steering Group, who held the green flag high during Child Protection Month in May and National Child Protection Week, that was celebrated from 29 May to 6 June this year.

The National Child Protection Week is commemorated in South Africa annually to raise awareness of the rights of children as articulated in the Constitution and Children's Act (Act. No. 38 of 2005). The green ribbon is worn as a symbol of commitment to advance children's rights and to be ambassadors for child protection. Ezrah Community Training and Development NPC celebrated Child Protection Month by implementing several child protection projects during May:

In collaboration with Bridges Retreat Centre – Outdoor Education Programme, we equipped 24 educators to implement our LEAD child participation model during an educator's camp. During Child Protection Week, Ezrah also trained Legacy Community Development and Love to Give in Stellenbosch on implementing our BuildSmart Parenting Mentoring Toolkit.

Our joy is even greater, when we see our child protection steering group members making a consorted effort to wear their green ribbons and to roll out different projects within their respective contexts. Ezrah kicked of the preparation for child protection month on a high note by sharing child protection resources and by equipping our child protection steering group members with skills on identifying and reporting child abuse. From the initial planning and ideas, our member organisations stepped out to implement different campaigns and projects, which were relevant to their context.

We are so grateful for the great progress and collaboration since launching our Child Protection Empowerment Programme in 2017 as well as all the lessons learned.

CHILD PROTECTION WORKING GROUP (MARCH TO MAY 2023)

MAIN GOAL:

To strengthen communication and collaboration between service providers so that children can receive quality support services from the child protection sector through a victim-centred, trauma informed approach to child protection care.

Progress report:

- We had some very fruitful meetings with the FCS (SAPS) commanders from the local Paarl FCS station as well as the Western Cape Forensic Social Services. The goals of these meetings were to build relationship and to get a better understanding of the mandate and role of forensic social workers.
- From these meetings, we were able to celebrate the progress and potentially expand the
 resilience project, facilitated by one of the working group members, Sp(i)eel Arts Therapies
 Collective to forensic social workers across the Western Cape.
- We were also able to expand the working group to include more delegates from our local child protection organisations and to work jointly on shared challenges by sharing resources, knowledge and connections towards resilience.



COUNTER CHILD TRAFFICKING ACTIVITIES

The Western Cape Counter Child Trafficking forum had three online meetings during this time period. As co-founder of this forum, Ezrah NPC is responsible for the secretariat position and plays an important coordination function between forum delegates.

As a result of forum meetings, the following outcomes were achieved during this time period (March to May 2023):

- 1. Ezrah in collaboration with Free to Fly and Missing Children South Africa presented an online session to the National Freedom Network's members during April. We shared more about the work and collaborations of the forum with the theme "An integrated response to child trafficking." From this presentation more members joined the forum.
- 2. The training work group started to collaborate on training standards related to child trafficking training and to share manuals, which can be used as foundation to develop training manuals of high quality.
- 3. The multi-disciplinary committee started to plan our Annual ThinkTank, which will be hosted on 20 July 2023. The themes, which we will unpack this year are focused on building a trauma-informed resilience strategy for counter trafficking role-players as well as the victims of child trafficking.



EDUCATOR CAMP SESSION (13 MAY 2023)

On 13 May 2023, Ezrah was privileged to facilitate a session on implementing Child Participation through our LEAD model to the 24 educators who attended the Bridges Retreat Camp during 12-14 May 2023. Here is some of the feedback received:

- I have learned a lot of strategies that will produce good results in academics and discipline which is a major problem in my school.
- Through the lesson I was given, I got many ideas how I can do child participation.
- Empowering and motivating to know if we as school can pull up that it can make an impact towards the community.
- It can start with a very simple task. Use what is in your hand.
- Learners learn more in an environment that they like and teaching must be fun and enjoyable in order to curb the dropout of learners.
- LEAD application for me means giving the learner a voice and giving them things to do (practical work), love and enjoy their schooling environment.
- I came to realise or learn that the whole process starts with me. Learners can be what I am or feeling on that particular day. The resource that I am taking back is to bridge the gap between educators and learners.
- Thank you for this beautiful session. Indeed we learned a lot and have strategies now to deal with our learners. Keep it up!




"I had an encounter last year where we were trained on the BuildSmart Parenting Tool.

For example Khula DG implemented a humane education project, while Inceba Trust and others celebrated WorldFoster Day on the 31st of May.


