Programme goal:

Child Protection Programme

To strengthen the larger child protection (CP) system in South Africa through collaboration and through empowering child-focused organisations as child protection champions.

Direct beneficiary reach:

Ezrah's clients are a combination of child protection role-players including child-focused NPOs, government departments, ECDs, NPO networks, SAPS and FCS, The breakdown in terms of child protection stakeholders that engaged with one or more of our projects for the time period **September to November 2023** is as follows:

Total number of individual persons: 78

Total number of NPOs and ECDs: 32

Global Ethics Day: ThinkEthics Online Course Campaign

During October, as part of celebrating Global Ethics Day, we launched a special campaign on Ethics in the Nonprofit Sector and gave free access to our ThinkEthics Online Course to advance ethical maturity on Global Ethics Day to eligible organisations.

Collaborative project: Child protection training for Orchard Africa

During November, we trained a group of community and church leaders from Orchard Africa on identifying and reporting child abuse. This collaborative project was so successful that we will continue with similar workshops for Orchard Africa during 2024.

Annual evaluation celebration of our child protection empowerment programme

In November, we presented the PERMA self-care model with our child protection community of community workers, social workers and ECD practitioners who provide child-focused services to vulnerable children. We also celebrated our joint progress through our annual evaluation celebration. CHILD PROTECTION WORKING GROUP (SEPTEMBER TO NOVEMBER 2023)

MAIN GOAL:

To strengthen communication and collaboration between service providers so that children can receive quality support services from the child protection sector through a victim-centred, trauma informed approach to child protection care.

Progress report:

- The focus of the 2023 working group meetings was to gain a deeper understanding of the respective roles and mandates of the different child protection role-players.
- During this quarter, Stellcare Stellenbosch and GoodHope Psychological Service shared feedback on their specific child protection role and how they collaborate and liaise with other child protection role-players.
- We had a successful meeting with Mrs. Annemie van Reenen: (Chief Directorate: Service
 Delivery from the Western Cape Department of Social Development to discuss key
 issues. The Western Cape Department of Social Development will present their mandate
 in January 2024.
- One of the promising outcomes that was achieved as a result of the working group
 activities is that Sp(i)eel Arts Therapies Collective implemented several successful
 resilience sessions with the forensic social workers and detectives of FCS units in the
 Western Cape during September and October. An evaluation meeting with all
 collaborators was held during November to celebrate progress and to plan the way
 forward for 2024.



COUNTER CHILD TRAFFICKING ACTIVITIES

The Western Cape Counter Child Trafficking Forum made great progress during this quarter, both through the main forum- and working group meetings:

Training working group

The training working group is in the process of compiling a specific counter child trafficking manual based on the current trafficking in persons' legislation, frameworks and standard operating procedures. During this quarter a framework for the manual was developed and during 2024 working group delegates will work on the content.

Multi-disciplinary working group

The multi-disciplinary working group are working on several spreadsheets to capture awareness campaign data. Some of this information was shared with the Western Cape Provincial Task Team on Trafficking for their report to the Parliament. This working group will also compile a service delivery directory to assist with referrals within a holistic care framework during 2024.

Collaboration with the Western Cape Provincial Task Team on Trafficking in Persons

Ezrah furthermore represented the Western Cape Counter Child Trafficking Forum at the Western Cape Provincial Task Team meetings during this quarter. It is encouraging that the Task Team is gaining a bigger child trafficking focus and is planning outreaches to several areas in the Western Cape during 2024 where there are concerns about child trafficking cases.



MONITORING AND EVALUATION

As part of our monitoring and evaluation process, we had several evaluation meetings with stakeholders during this quarter to celebrate progress and to plan the way forward for 2024:

Resilience meeting with SAPS-FCS, Sp(i)eel Arts Therapies Collective and Thuthuzela Care Centre, Paarl

During the evaluation meetings of the resilience project, we celebrated that forensic social workers could learn resilience tools which they can use in the personal and professional lives. We also incorporated feedback into our planning for 2024.

BuildSmart Meeting with Love to Give, Legacy, RealDeal Trust and Good Hope Psychological Service

Key take-aways from this meeting include the value of training combined with mentoring, providing a reflective space so that facilitators can make the training their own and having regular follow-ups to help contextualise the training.

Child protection evaluation meeting with Orchard Africa

During this meeting, we celebrated the value of intergenerational peer learning in applying child protection knowledge within cultural context. We also planned the general themes for the 2024 child protection workshops which will include volunteer screening and management to create safe spaces where children matter.

REFERRAL WORKING GROUP ACTIVITIES

We will continue within working group meetings to draft a referral and communication flowchart to support child victims of sexual exploitation in the Cape Winelands-area and wider Western Cape.



COUNTERING CHILD TRAFFICKING

Through the Western Cape Counter Child Trafficking Forum, Ezrah continues to play a vital role in coordinating joint efforts to respond to child trafficking cases and to build models of collaboration.



EXPANDING CONSULTANCY SUPPORT SERVICES TO NPOS

We are currently implementing a consultancy project for **Join Bands not Gangs** to assist them with strengthening their services to vulnerable children and communities.



ONGOING COLLABORATIONS

We value our collaborations with both government departments and NPOs to address child protection challenges.

Our main collaborators include **Sp(i)eel Arts Therapies Collective, SAPS-FCS**,
the **Thuthuzela Care Centre, Paarl**, **Orcard Africa, RealDeal Trust** and **Good Hope Psychological Service**.
